

TERMS AND CONDITIONS
FOR PARTICIPATION IN EVENTS ORGANISED BY
THE POLISH NATIONAL ASSOCIATION OF DOCTORAL CANDIDATES IN 2026

§ 1. General provisions

1. These terms and conditions set out the rules regarding registration, participation and withdrawal from events organised by The Polish National Association of Doctoral Candidates, hereinafter referred to as the “Event”.
2. The event is organised by the Polish National Association of Doctoral Candidates, based in Warsaw at 12/6 Nowogrodzka Street, 00-511 Warsaw, entered in the register of associations, other social and professional organisations, foundations and independent public healthcare institutions maintained by the District Court for the Capital City of Warsaw in Warsaw, 12th Commercial Division of the National Court Register, under KRS No. 0000566784, NIP: 7010333304, REGON: 14598982000000, hereinafter referred to as the “Organiser”.

§ 2. Event registration

1. Registration for the event takes place in two stages:
 - a) the first stage is to correctly complete and submit the online application form provided by the Organiser;
 - b) the second stage involves the Organiser verifying the registration and the Participant receiving official confirmation from the Organiser that they have been accepted to take part in the Event.
2. Upon receiving confirmation of their eligibility to participate in the Event, the Participant shall be deemed to have entered into a service agreement between the Organiser and the Participant (or the entity nominating the Participant, e.g. a university or institute).

§ 3. Terms of payment

1. The cost of attending the Event is PLN 800 gross per person if accommodation is provided by the Organiser, or PLN 400 gross per person if no accommodation is provided.
2. The participant/applicant undertakes to pay the fee in accordance with the pro-forma invoice or VAT invoice issued, within the time limit specified in the document.
3. Failure to make payment by the deadline specified in the document does not constitute a withdrawal from the Event.

§ 4. Withdrawal from the Event

1. Participant have the right to withdraw from the Event in accordance with the following options.
2. Withdrawal from the Event and notification of a replacement must be made in writing (by email) to the following address: wiktoria.wilczynska@krd.edu.pl, otherwise it will be deemed invalid.
3. Withdrawal from the Event after submitting the form, without the need to arrange a replacement or pay the full fee, is only possible up to the date on which the online application is open.
4. If a Participant withdraws from the Event after having been selected to take part, they are permitted to appoint a replacement to attend the Event in accordance with the preferences specified by the original Participant, at no extra cost, provided that the Organiser is notified no later than 48 hours before the start of the Event.
5. In the event of withdrawal for valid unforeseen reasons, the Organiser may allow the Participant to withdraw without being required to find a replacement or pay the event participation fee; however, the final decision in this regard rests with the Organiser.

§ 5. Changes to the programme and cancellation of the Event

1. The Organiser reserves the right to make changes to the event programme for reasons beyond their control.
2. If the Event is cancelled due to the Organiser's fault, all payments made will be refunded in full within 21 days.

§ 6. Final provisions

1. In matters not covered by these terms and conditions, the provisions of the Civil Code shall apply.
2. Any disputes shall be settled by the court with jurisdiction over the Organiser's registered office.
